

2008 TEVCO LOGO CONTEST

TEVCO NEEDS **AN OFFICIAL LOGO!**

This contest is to select an official logo for TEVCO. It is intended that the selected logo will be used on all TEVCO publications, which includes: premium lists, catalogs, letterhead, on the home page of the website, business cards, banners and signs, ballots, etc. Use of the logo will be restricted to official TEVCO business, communications, publications, clothing and other apparel, etc.

CONTEST RULES:

1. WHOM MAY PARTICIPATE:

- Any and all active (ie, current dues paid in 2008) members may participate.
- Participating members may submit their own entries.
- Non-members may submit entries, but these must be submitted through an active member. (*This allows members' friends and family to participate.*)

2. WHAT TO SUBMIT:

- Any theme is appropriate, given that it must not be offensive to others and contain only legal images or themes.
- Designs may, but are not required to contain the words "Trail's End Vizsla Club of Oregon" or "TEVCO".
- Each image submitted is considered a single entity.
- Entries may be submitted in color, black and white, or grey scale.
- If colored entries are submitted then a black & white or grey scale example (ie, a photo/Xerox copy of the colored image must also be submitted.
- All entries must be an original creation, and in final format, reproducible in both color and grey scale. That is, each entry must not be the copyrighted work of another, unless the copyright is transferred to TEVCO.
- Each entry should be no larger than 8½ x 11 inches and no less than 5 x 7 inches.
- Each image submitted must be accompanied by a photocopy (ie, "Xerox" copy) which is no larger than 8½ x 11 inches and no less than 5 x 7 inches.
- Black & white, colored and grey scale images must be amenable to clear reproduction by photocopying.
- Please submit all images and their photocopies in protective plastic shields (ie, sheet protectors).
- Digital images may be submitted as jpeg 300dpi TIF or PDF files or as images in a PowerPoint program. Each digital image submitted must be accompanied by a color print *and* a photocopy, as described above. Please submit all digital images in as high a resolution (ie, minimum 300dpi) as possible.
- Following submission, entries cannot be revised. Any revisions, redesigning, etc, must be submitted as a new entry.

- **PLEASE DO NOT LABEL YOUR ENTRY WITH AN IDENTIFYING NAME OR NAMES OF AUTHOR OR ARTIST.** *(The person receiving entries will record their origins, authors, etc. This allows the voting to be done without knowing who contributed the entry.)*

3. SUBMISSION DEADLINE:

- All entries must be received at the address below by July 1, 2008.

4. WHERE TO SUBMIT ENTRIES:

5. OTHER REQUIREMENTS:

- All entries must be received so that it is clear who the contributing member is and who the contributing artist is. **HOWEVER, PLEASE DO NOT LABEL THE ENTRIES THEMSELVES WITH IDENTIFYING NAMES. VOTING ON ENTRIES WILL BE DONE WITHOUT THE MEMBERS KNOWING WHO IS THE CONTRIBUTING AUTHOR AND ARTIST.**
- A copyright deliverance document assigning copyright (ie, ownership) of the entry to TEVCO shall be required for the winning logo.
- All entries become the property of TEVCO and may be used by TEVCO in other appropriate and official communications.
- Use of the TEVCO logo and other submissions is restricted to official and appropriate TEVCO communications and other uses, unless their use is granted in writing by the Board of Directors and Officers.

6. HOW THE WINNING ENTRY WILL BE CHOSEN:

A vote of the membership shall determine the winning entry. Images of the entries, in color as necessary, will be printed in the July Newsletter for voting by secret ballot. Ballots may be submitted at the July General Meeting or via mail-in ballots that will also be printed in the July Newsletter. All votes must be received by the Secretary by August 31, 2008. The winning entry will be presented at the September Picnic (September 27, 2008) and also printed in the next published TEVCO newsletter.

- Votes may be cast by active members only and ballots will be submitted to the Secretary for tabulation.
- The image with the most votes will be designated the winner and will become the official TEVCO logo.
- There will be a re-vote in the event of a tie vote.

7. PRIZE TO MEMBER SUBMITTING WINNING ENTRY:

One year free TEVCO membership.
