You will pass a sign letting you know you are on the West Units. The road will eventually turn into a dirt road; you will cross two cattle guards and then make a sharp right turn remaining on the dirt road. Keep following this road until you see our camp (on the left). If you have reached the river, you have gone too far. Parking permits are required on the Island. They are available for day only or yearly use. You can purchase the permit online at http://www.dfw.state.or.us/online_license_sales/what.asp or at the 7-11 in Linnton or at the little store on the Island.

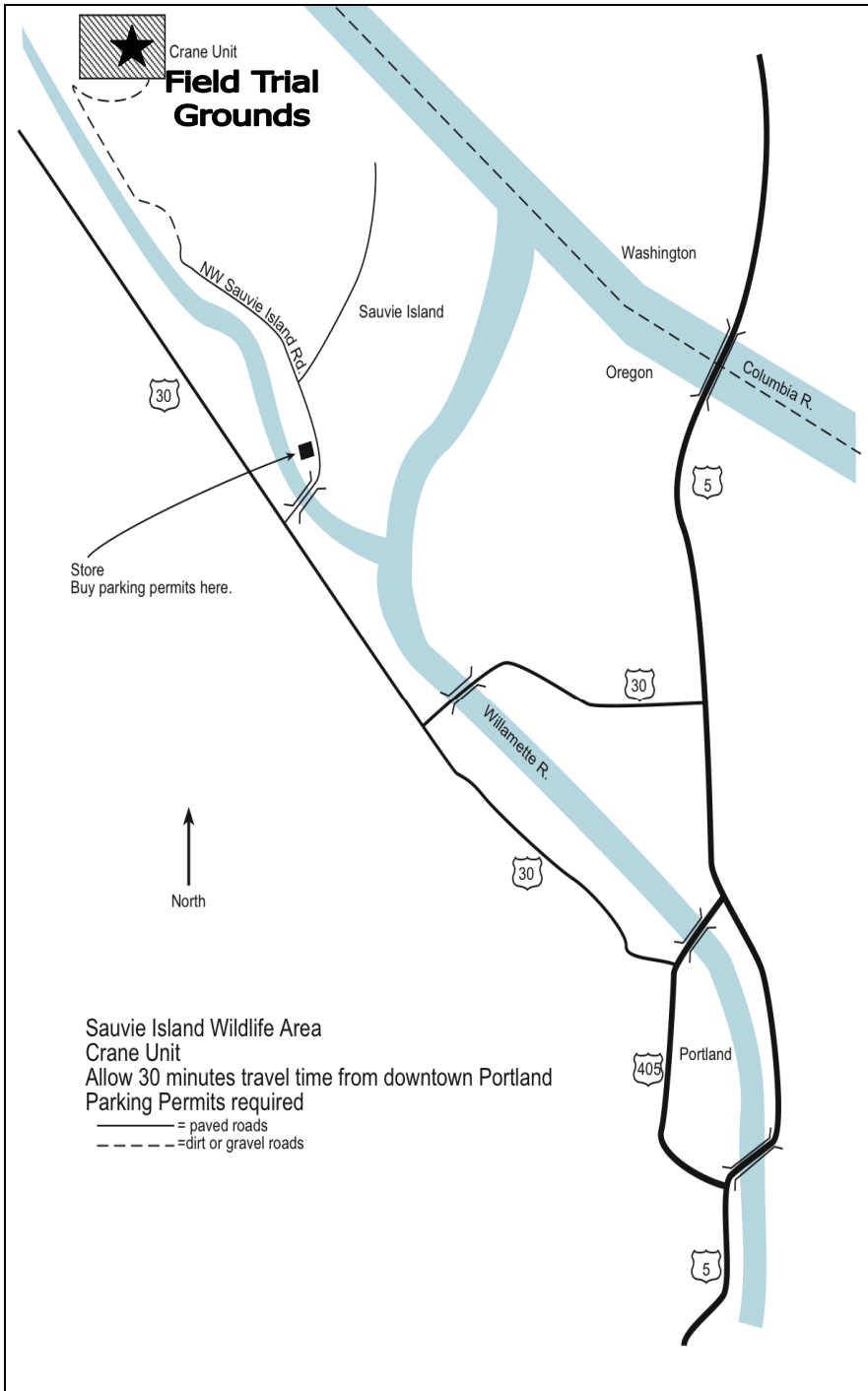

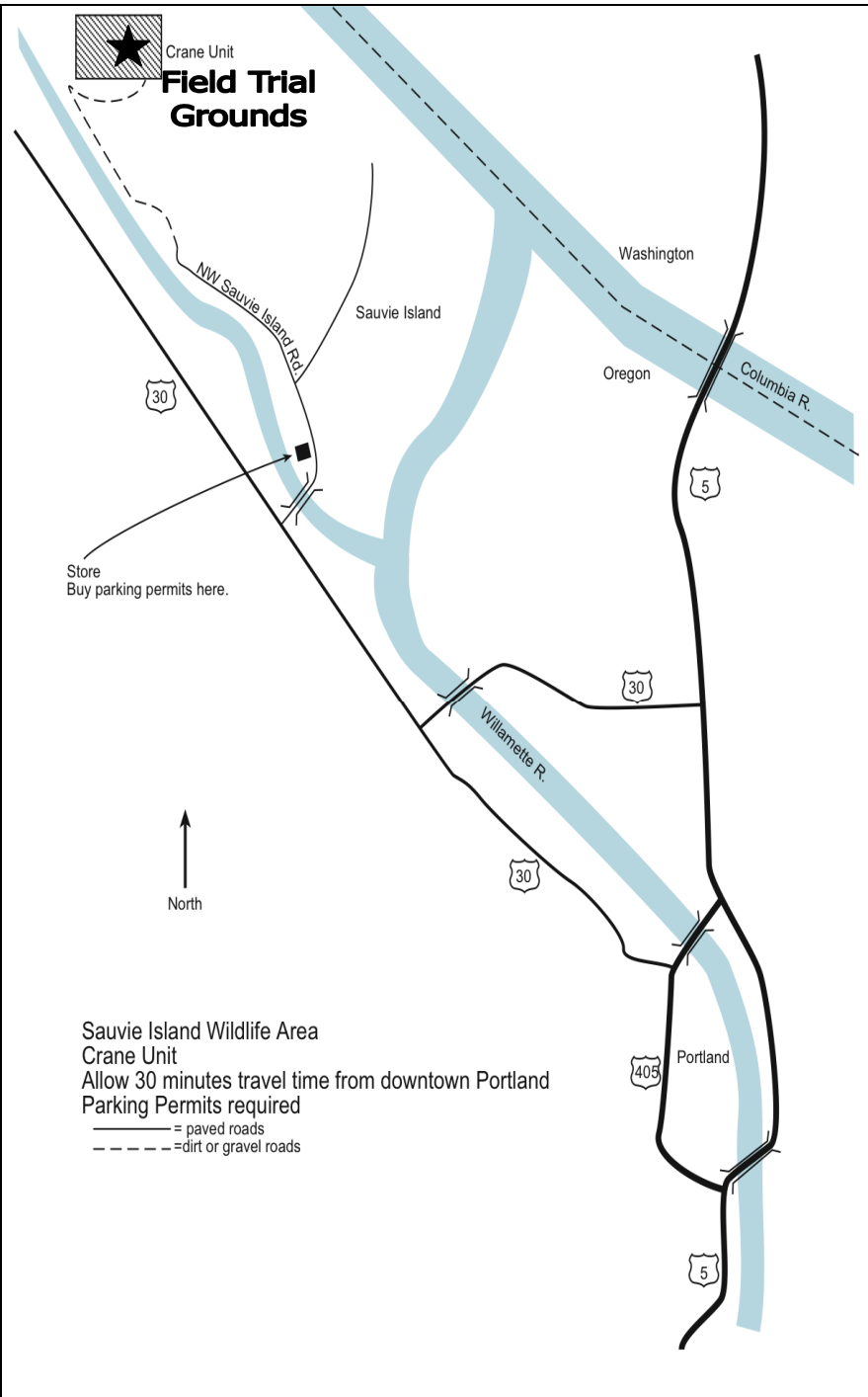
